- 4) If the remaining amount is not paid within the stipulated period, the **EMD** amount will be forfeited by the officer conducting the auction. The second bidder will get the opportunity to buy the items.

- 6) The furniture and other items auctioned will be open for physical examination on **17-03-2020 and 19-03-2020 from 10.30 AM to 5.00 PM** and the rate list will be published.
- 7) The bid amount will be inclusive of Goods and Services Tax.
- 8) Bidders registered under GST Act should submit the copy of self-attested GST certificate.
- 9) The applicable GST of the materials will be paid to the government by the Officer conducting the auction.
- 10) If the original value of the auctioned material is less than Rs. 1 Lakh, (a) the bid amount of the next bidder should be more than a minimum of Rs. 1000/- than the first bidder and (b) if the original value of the material is more than Rs. 1 Lakh, the bid amount of the next bidder should be a minimum of Rs. 5,000/- more than the first bidder.
